Long Stratton Bypass is now open with full completion due in October. A new initiative is due to be rolled out across Norfolk using AI to identify elderly residents who are vulnerable to falls and escalating needs to provide proactive intervention to enhance safety and wellbeing of those at highest risk. NCC has secured funding to enhance local transport infrastructure over the next four years. This should help reduce congestion, improve accessibility, enhance public transport and promote sustainable travel.

6. To receive the Clerks Report and an update on any correspondence received:

Highways have replied to several of the outstanding issues:

Confirming that the chevron sign on the A140 roundabout has now been replaced. Additional repeater signs have been installed on Bungay Road and the Village gateway signs have been installed.

Terrace Road/Low Road investigations found no evidence of sewage. If this reoccurs it needs to be reported to Anglian Water. However a short length of drainage pipe has been damaged by tree roots which needs to be replaced and should be completed before winter.

Pavement to Diss should have works completed end of September – Clerk to chase this.

The Highway Ranger Service was introduced in 2011 after a successful trial to enhance coordination between local highway teams and Town and Parish Councils. Its goal is to improve community engagement and address highway issues promptly between scheduled inspections.

7. To receive an update on the approach from South Norfolk Council to explore reallocation of the \$106 funds to another project:

13. To report any incidents of overflow, spillage and discharge into the river during the month

28th August 2025 Anglian water visited due to a blockage in the pipeline from Robinson Road to the pump station on Bungay road.

The engineer's concern was any discharge in the ditch and on to the river. There were no problems with overflow or discharge at that time.

The engineer told me his manager said they would be in deep trouble if we again have macerated sewage in the ditch along lot 2.

As Anglian Water does not have a licence to do this the environmental agency could fine them heavily.

A few days later a contractor for AW arrives at Robinson Road, 8 men in 4 vans to inspect the pipeline. using cameras and clearing equipment managed to clear roots and debris from the pipe. They could do no more as another team that was supposed to clear all the overgrown bushes had not arrived.

We now wait for the various teams to organize themselves to carry out the necessary work, more needs to be done as roots would indicate a broken pipe or at least poor jointing.

These blockages happen about every 3 to 4 months.
